General Terms & Conditions

1. TSSL shall provide Exhibitor with the Deliverables as agreed between the parties and more particularly stated in the Annexure B hereto.
2. The Parties agree as under:
 - (i) TSSL shall design, develop, host and operate the Exhibition and further advertise the same vide its extensive network.
 - (ii) TSSL shall facilitate the program development, content management and event execution for the Exhibition.
 - (iii) TSSL shall have and maintain full editorial control over the Exhibition.
 - (iv) TSSL shall have and maintain complete control over the Exhibition.
 - (v) TSSL will undertake the marketing communications efforts to promote the Exhibition within India to publicize and profile the event.
3. Exhibitor agrees that the Consideration shall be paid as under:
 - (i) 100% on or before signing of this Space Booking Form; - **Tranche 1**
4. Exhibitor shall be liable to pay interest @18% p.a. in the event of any delay in the payment as agreed above from the date the payment became due till realization.

5. Exhibitor agrees that in the event of non-payment of the Tranche 1; TSSL shall send a payment reminder to Exhibitor and in the event the same still remains unpaid within two days of such reminder, then your participation for the Exhibition shall be deemed cancelled and the consequences as mentioned in below clause 6 shall apply.
6. In the event, Exhibitor wants to cancel its participation for the Exhibition for whatsoever reason, the same shall be subject to below:
 - (i) 45 days prior to the date of Exhibition - 50% of the Consideration shall be payable by Exhibitor to TSSL;
 - (ii) Less than 45 days prior to the date of Exhibition – 100% payable by Exhibitor to TSSL.
7. Any additional representation of any other group company (ies) or strategic partners of Exhibitor, must be requested for, in writing and shall be as agreed by TSSL at its sole discretion. TSSL reserves the right to charge a premium for every additional company representation.
8. In the event Exhibitor is provided with booth area as part of their Deliverables, TSSL will communicate regarding, setting up, maintenance, dismantling of the booth and other rules & regulations regarding Exhibition to the Exhibitor through an **Exhibition Manual**. The terms of the Exhibition manual shall be binding on the Exhibitor.
9. TSSL will inform about the expected Speaker/Delegates for the Exhibition, in advance to Exhibitor. However, any changes in the expected Speaker/Delegates shall not have any bearing on the deliverables agreed by TSSL and payment obligations of Exhibitor.
10. TSSL reserves the right to revise the Date or Venue of the Exhibition or shorten the duration of the Exhibition without any liability of whatsoever nature.
11. All intellectual property rights including copyrights, trademarks, etc., in and to the Exhibition shall be held and solely owned by TSSL only. Exhibitor, allows TSSL to use its name, logo, trademark, service mark & other Intellectual Property for the purpose of deliverables under this engagement, whereas Exhibitor existing ownership of Intellectual Property shall continue to vest with them.

TSSL shall not have any liability to Exhibitor, if it is prevented from or delayed in performing its obligations due to happening of any force majeure event (including but not limited to fire, flood, storm, war, any executive/judicial order or civil strike or any other happening of event beyond control of TSSL).
